I will try to give you a synopsis of what has expired since you received the invitation to the meeting in VA on June 21.

We arrived in VA a few days before the meeting and went by to check the cemetery. What a surprise, our fence had been removed from around the cemetery. The lot had been cleared and four surveyors staked were around a wooden fence some seven feet to one side of the original fence, and a road was going in nearby. After talking to Walton Bondurant, attorney, I contacted Mr. Lewis, attorney for the sub-division and part owner of the sub-division. With the help of David Holland, and John Bondurant, we made a date with Mr. Lewis to meet on the site on the morning of June 21.

We met with Mr. Lewis, and had a copy of the plat from Mary Epling, which clearly showed the cemetery; and also a letter from Division of Historic Landmarks, Commonwealth of VA which clearly stated that we had every right to the cemetery and access to it. Mr. Lewis agreed to work with us with the hope of coming to an amiable agreement.

A number of Bondurant cousins, who would not be at the meeting in the afternoon had come by the cemetery site that morning and all were in favor of going on with our project.

At the afternoon meeting, a good number of Bondurant cousins showed up and such enthusiasm for such a warm June day. We formed a Bondurant Family Ass'n. with dues of \$5.00 a year to defray the cost of the newsletter, the carry on the project of restoring the cemetery, meeting again in VA in Oct. 1988, and having a genealogical committee to help others with their genealogy on the Bondurant family. The meeting was very informal and all committees were filled by volunteers.

Mrs. Mary Bondurant Warren will serve as the genealogy committee and with the files from Mrs. Mary Epling, and your genealogy charts, will compile them.

Mr. Walton Bondurant, Peggy Rutledge, and Susan Epling will serve on the cemetery committee. Mr. Bondurant has been in contact with Mr. Lewis and it looks favorable that we will have the old cemetery plot back soon.

Susan Epling will see about our meeting in Oct. 1988. Make your plans now to come to this.

We will need your help as so far, we only have about enough money to cover the cost of a new fence. We will need a fund for a marker, and of course we will always need a fund to maintain the cemetery.

I am acting as the treasurer until we have another meeting and elect a treasurer. I will be glad to accept your money. We will also need to have your dues, so we can continue to keep you informed of our progress.

We will gladly consider any idea that you might have on all of this. We hope to get all of you involved in this.

The following information is from Don Bondurant who spent his later years in Heber Springs, AR and who was responsible for the latest proof on the genealogy of our ancestor, Jean Pierre Bondurant. It had long been thought that Jean Piere was the son of Joseph and Elizabeth Ann Chastain Bondurant. There was a Dr. Joseph Bondurant in Lyon about 1650, and in 1979 some of the descendants of Jean Pierre Bondurant wrote a short history of the family based on Joseph as the father of Jean Pierre.

According to information from American correspondents, the Dr. Joseph Bondurant and his son Jean Pierre were "discovered" by Dr. P. M. Agree, also a descendant of Huguenot refugees and relation of the Bondurants, author who about 1930, wrote "History of the Agee Family". He did not give the source of his information and his notes are now lost.

In view of the uncertainty, Don undertook on his own research. Those of us on Don's mailing list received periodic reports of his progress. After Don's death a few years ago, Mary Dennis of Nashville was called in to help preserve his notes. With the help of many of us, copies were made and placed in various libraries. The originals were placed in the State Library in Richmond Virginia. Copies are in the libraries of the universities at Murry, KY; Martin, TN; and TN State Library. I understand that the copy at the TN State Library is now on microfilm.

Since this hopefully will be only the first installment on the genealogy of Jean Pierre Bondurant, I will try to give proof as I see it and comments from Don's notes. I

am sorry that my computer or printer does not have the capability to print the French punctuation signs.

These are extracts from the Manuscripts of Fernand Teissier-archive curator.

According to the register of the reformed churches of Hautes Cevennes-Gevaudan found in the archives of the court of appeal of Nimes.(These notes are kept at the Society of History of French Protestants in Paris, ref. MS 422).

Reformed church of Barre des Cevennes south east of Florac, department of Lozere. October 28, 1676-was celebrated in the church of Barre the marriage of Jean-Pierre Bondurant, sir de Cougoussac, a middle class citizen living in the town of Genolhac, age 40 years, and of Miss Gabrielle de Barjon, age 34 years, living in Barre. Witnesses were: Mr. Aldebert de St. Martin; Seigneur de Barre (Lord of Barre); Jacques d' Arzillan, wine grower; Jacob Agulhon, pharmacist; Jean Chambonnet, notary, who signed with both parties.

Observation: Cougoussac could be the place called the community of Servieres approx. 10 Kilometers North-West of Mende near another place called le Villaret. Genolhac is now in the department of Gard at the border line between Gard and Lozere.

From the Society of the History of French Protestants.

Pierre Bondurant at the very beginning of the 18th century lived in the hamlet of La Roche, parish of St. Andre de Lancize(Lozere), but also at Genolhac. He had at least one son, Jean. A letter was found dated from Geneva the 2nd or 9th of December, 1712 written by Marie de Roux de Meinadier to her cousin, the wife of Pierre Bondurant. Remarkably written as well for the penmanship as for the style on excellent paper, very legible and gives precious information. This Marie De Roux de Meinadier had gone out of France "for causes of religion without any doubt". She speaks of children of her cousin and principally of the youngest established in Lyon and with whom she seems to have correspondance. She speaks of her sister, her brother, and the son of the latter, several nieces who are with her in Geneva.

We therefore have a first proof that members of the Bondurant family from the Hautes Cevennes left France after the revocation of the Edit of Nantes. Moreover, there was in Lyon a Bondurant but that was in 1712 when this letter was written.

It seems as if the Bondurants were already living in Genolhac as soon as the beginning of the 14th century and they were already important people.

This country of mountains was very isolated at the end of the 17th century and barely accessible for lack of roads, was the theatre of the terrible War of the Camisards which began circa 1702. But as early as the revocation of the Edit of Nantes in 1685 the Protestants were persecuted relentlessly. And many Cevenols(people of the Cevennes) left their country before 1700. First they went to Switzerland, from there they continued to Germany, Holland, and England.

The essential part rests, on the proclamation made 4 January 1718 by Mr. Francois Bertrand, Royal Notary (AD Lozere III E 8564) for the benefit of Gillaume de Latour, Seigneur d'Aquebelle, whom Françoise Argenson employed to defend her interests against Ambroise Lafront; Andre Bondurant, Apothecary of Genolhac; and, generally, against

the "holdings and occupation of the property abandoned by J\_\_\_ Bondurasnt, late son of Jean Pierre Bondurant, Sieur de Cougoussat," fugitive from the Kingdom because of religion".

That document is not exact as to the date, Francoise Argenson was a niece of Jean Pierre Bondurant, Sieur de Cougoussat; and we have to return to the conflict of opposing interests, before 1718, of Andre Bondurant, Apothecary, son of Antoine Bondurant and Suzanne Raoux, and also first cousin of the Sier de Cougoussat.
