Happy Holidays to the Bondurant Family,

We had a great year this year. It was our first meeting in San Antonio, Texas. This is a beautiful historic city. Most people know it as the home of the Alamo and a river walk.

The San Antonio River was discovered in 1535 by Alvar Nunez Cabeza de Vaca. On St. Anthony’s Day in 1691 the then Spanish governor, Los Rios, renamed the river from the First Nation’s name of *Yanaguana* to the San Antonio River in honor of Saint Anthony. It had been a very important travel route for the First Nation and Spanish as they traveled from the Gulf of Mexico. The Spanish built missions on the river and many others in San Antonio area. During our visiting weekend the missions were celebrating their recent honor from UNESCO (The United Nations Educational, Scientific and Cultural Organization), which has named five of them as a World Heritage Site. These five missions are the largest concentration of Spanish Colonial church buildings in North America. Some of the group took the opportunity to visit the missions during the weekend.

In the 2015 annual meeting on Saturday, the family history presentation was delivered by Michael Salzburg-Felts. Michael spoke and displayed pictures of his family and ancestors, giving us wonderful presentation on his Bundrant side of the family. He and Kevin also hosted and catered the meeting this year in their home. We thank both Michael and Kevin for sharing their home and taking their time to make this year’s meeting a success.

**THE 2015 ANNUAL MEETING MINUTES  
IN SAN ANTONIO, TEXAS  
October 16-17, 2015**

In the absence of our President, Ed Bondurant, Vice President Marcelle Hoffman opened the meeting at the Hilton Garden Inn. "Meet Your Kin" brought some new kinfolks and their memorabilia. Don and Joyce Bundrant of Argyle, TX, came with scans of his Bundrant ancestors, and their graveyard in Bell and Coryell Cos., TX. Pete and Judith Felts, parents of our host Michael Salzburg-Felts, came to meet these new relatives.

Jan Moses, Ruby Smith's son, had created a disk of views of the Génolhac, France, area which he had gleaned on the French version of Google. He made enough disks for each of us to have a copy, and during the evening we looked at the sites, and made comments on their significance.

Our meeting on Oct. 17th was held at the home of Michael and Kevin Salzburg-Felts. We were joined by Mary and Joseph Lambert, formerly of IL, who now live in San Antonio. Mary is the descendant of Maurice/Morris Hamilton and Mary Bondurant. Again Vice President Marcelle presided. Minutes of the 2014 meeting were read and approved, and the report of our Treasurer Amy Sanders was distributed to those attending. It will be published in the newsletter in December.

David Bondurant reported on the website, and after a discussion, he will investigate how we might collect dues and membership electronically. We voted to make this possible.

Mary B. Warren expressed her opinion that BFA should revert to one-year terms for officers, which we had when the Association was founded. She suggested that it be publicized in the newsletter and brought to a vote at the next meeting. If passed, those officers elected in 2017 would serve one-year terms, but could be reelected by the membership for successive terms.

Next year the BFA meeting will be held at or near Charlottesville, VA. Date may be either Oct. 14, or Oct. 21, 2016; Marcelle will investigate conflicts there with other activities, particularly Homecoming at U VA, or football games. The date should be selected by the time our next issue is to be published.

Michael Salzburg-Felts gave an interesting PowerPoint presentation on his ancestor William Henry Harrison Bundrant, born in 1841, Hawkins Co., TN, and died there. He served during the Civil War in the Confederate forces, and became the progenitor of a large family of children.

Lucille had been a very active member of the First United Methodist Church. Prior to World War II women did not work in pipeline companies. She and five other ladies found themselves at Shell, designated as the very first pipeline women, working the switchboard and doing secretarial and clerical duties in a workplace only previously performed by men. She continued working in the oil industry until her retirement. She enjoyed visiting with friends, good food, a good game of cards or dominoes, and spending time with her family.

Survivors include two grandchildren, Charlotte Woodruff and her husband, Russell, and Kenneth A. Ryan and his wife, Angie; four great-grandchildren, Darrell Woodruff, Chase Woodruff, Joshua Ryan and his wife, Janie, and Shea Ryan; and one great-great-grandson, Steven Anthony Ryan and many other relatives and friends.

Lucille was preceded in death by her parents, husband and only son, John Henry Ryan. **Kenneth Andrew Bondurant**, 92, formerly of Cainsville, OK, died Saturday, October 3, 2015 at Bethany Care Center. He was born July 8, 1923, in Gilman City, Missouri, and passed away October 3, 2015 at Bethany Care Center. He was the son of Ross and Neima DeGraw Bondurant.

At a young age, Kenneth's family moved to Oklahoma where his dad worked at a refinery in Cushing, Oklahoma. After a few years they moved

to Cainsville, Missouri, where his dad sold cars. His dad's interest in cars become very important to Kenneth, and he never lost interest in the cars of his youth. He loved to share memories of the different cars that were part of his growing-up.

On January 27, 1943, Kenneth was drafted into the United States Army. His basic training was taken in Texas. Upon completion of this training he requested to be sent to Europe to avoid the hot weather in Texas. His transfer from Texas took him to England where he was part of the D-Day invasion. His group didn't land on Omaha Beach until June 7 because of the heavy amount of men and materials being transported to the beach. He served his country as a light mortar crewman, and served in battles and campaign in Normandy, Northern France, Rhineland, and Central Europe. For his service he was awarded four campaign bronze stars, and the good Conduct Medal. On January 11, 1946 he was separated from the Army at Jefferson Barracks, Missouri.

Kenneth married Joanna Maple October 15, 1946, in Troy, Kansas. Soon after they were married, they purchased a home in Cainsville and lived there throughout their marriage. Until his retirement, he was self-employed in the trucking business and later he was an agent for Standard Oil. During their marriage Kenneth and Joanna collected several old cars, ranging from a Model A and Model T Fords, and Studebakers. In 1989 they won first place in the 1959-1961 Golden Hawk Class at the National Studebaker Show in Las Vegas, NV.

Kenneth was a caregiver. He looked after his mother until she passed in 1992, did errands for his sister-in-law, Audrey Gay Giegerich, and anyone who need a ride to the doctor or hospital he was always willing to help. He also enjoyed listening to country music. Kenneth attend the Methodist Church in Cainsville as long as his health permitted, and served as a Trustee.

Kenneth was preceded in death by his wife Joanna, parents, and a brother Doyle Wayne. Surviving family include 12 nieces and nephews, and dear friend Nadine Thompson. Kenneth will surely be missed by his many friends and family.

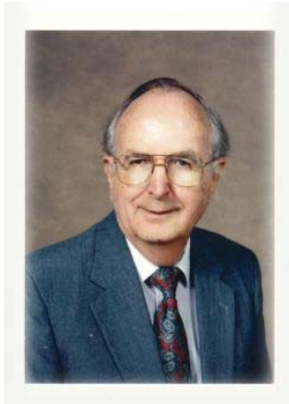

**Mason E. Bondurant**, 91, of Little Rock died on November 9, 2015. Mason was born on April 18, 1924 in Ensley, Alabama, the son of Robert Lee and O'Dahlee Bondurant. His parents and his sister Bettye Strange preceded him in death. He was a graduate of Howard College (now Samford University) and Southwestern Baptist Theological Seminary. He married Margaret Montgomery in Hartselle, Alabama on June 4, 1946.

He began preaching when he was fifteen and was ordained at nineteen. He loved to tell the story that he went to the Birmingham Jail to preach and that he had a captive audience. Mason and Margaret were in the Seminary together and their first churches were small ones in Oklahoma. Mason decided to join the Army when the Korean Conflict began. He served as a Chaplain and had a jeep that he drove along 50-100 miles of the front line to preach to any and all servicemen. One man had a deep need to be saved and wanted to be baptized. It was freezing weather but Mason knew this man was in desperate need of some feeling of safety. He baptized this man in an icy river. Before Mason left Korea he was given a General promotion to Captain.

When he returned from Korea he was assigned to Fort Chaffee in Arkansas. There he was presented The Bronze Star for his dedication to serving on the frontlines. He became pastor of Trinity Baptist Church in Fort Smith, his next church was First Baptist in Dumas, and his third pastorate in Arkansas was First Baptist Jacksonville. During this time he also remained a Chaplain in the Army Reserves, retiring as a Lt. Colonel. After over thirty years serving as a pastor, he and Margaret decided to become Foreign Missionaries. They were assigned to Venezuela but were unable to get Visas so they served first in Quito, Ecuador and then later in Maracaibo and Caracas in Venezuela. After being at home for a short time, they felt the call to serve again and went to Senegal, West Africa.

They came home again and Mason was interim pastor of many churches in central Arkansas. He and Margaret were a wonderful team. One church nick named them Barn Rat because the name is not an easy one. Another church gave him a plaque with a rabbit because during his sermons he would often tell a story that he called chasing rabbits. His last pastorate was an Immanuel Baptist mission, retiring at 85. He will be remembered fondly by many as the preacher in the cowboy hat.

He is survived by his loving wife Margaret, four children Paula (Steve) Melody of Fayetteville, John (Debbie) Bondurant of St Louis, Mo, Philip (Amanda) Bondurant of Fayetteville and Joanna (Steve) Wilson of Cabot, nine grandchildren Meredith (Andrew) Melody-Hubbell of Little Rock; Isaac (Jennifer) Bondurant of St. Louis, MO. Hannah Bondurant of Durham, N.C., and Daniel Bondurant of St Louis; Paul Bondurant of Fayetteville, Samuel Bondurant of College Station, TX, and Sarah Bondurant of Fayetteville; Alicia (Patrick) Birmingham of Jacksonville and Zak Wilson of Cabot; and seven great grandchildren Emma Kate and Evelyn Hubbell, Jonathan, Caleb, and David Bondurant, Ray and Meara Birmingham.

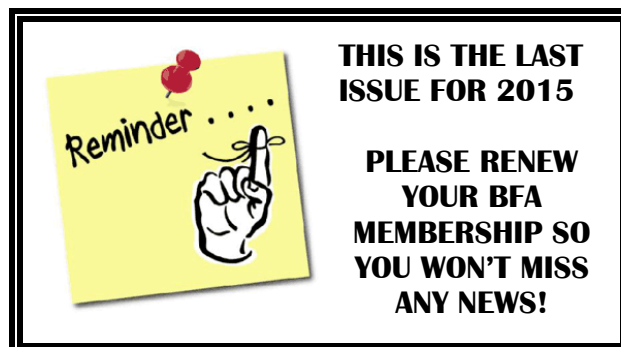
