#### **Old Business**

No funds from the treasury were used this year to keep up the cemetery; it has been done "gratis" by a neighbor. Ginny and Carroll Wray reported on visiting with Mrs. Butler who lives in the house adjacent to the Bondurant cemetery near Midlothian. She suggested that installing a gate in the fence would make it easier to keep up the gravesite. This suggestion was turned down, since the fence sections are bolted at the corners; when necessary the bolts can be pulled and a section removed for maintenance. Remounting the section only requires reinserting the bolts, and tightening the nuts.

The young magnolia tree, spared when the site was cleared, has now grown much larger, nearly covering the grave lot. In a few years, it's heavy shade will prevent weeds from growing within the enclosure. Until then, an effort will be made to employ someone to keep the lot clean. Carroll will talk to the neighbors about this.

#### **New Business**

A motion was made, seconded, and carried that we begin publication of a Bondurant family book. Mary Warren was appointed Chief of Publications.

First book will be on the French research already completed, with photographs of the sites, facsimilies of some documents, maps, etc. This book will be hardbound, and should be ready for sale before the next meeting. Estimated cost \$30-40. When this is published, we can turn our attention to preparation of the American family from 1700-1800.

A portion of the videotape made by Lisa David of the dedication ceremony at Genolhac, and the party in Madame Breton's garden was shown. This tape is being professionally edited, and expanded to include other Bondurant sites in France, and explanatory material. This tape will be a companion to our first volume of Bondurant family history.

After lunch the group went to visit the gravesite, then on to see the new Huguenot Society Library, and the former Manakin church near Midlothian.

Slides of the French trip made by Ruby Talley Smith and Irv Bondurant, and the videotape of Hix and Lil Bondurant were displayed on Saturday night.

Several persons have asked if there will be another chance to visit France and Genolhac next year.

Your inquiry is not a committment. If there is sufficient interest, we will publish a prospectus in the next newsletter. Going in either spring or fall in order to miss the throng of European tourists, and the hot summer weather, has been suggested!

A motion was made, seconded, that we return the antique "boot" given to the Association by the citizens of Genolhac, to the town with a suitable card or inscription. It can form the centerpiece of a display in the town museum; they don't have such a boot!

On Sunday morning the "Executive Board" met for the first time. We will obtain a suitable photograph of the "boot" and write a feature story to be submitted to the *MIDI-LIBRE*, the newspaper in Alès, France, which gave us such good publicity. Then the "boot" will be shipped back to Mayor Olivier to be shared by the Bondurants and the Genolhac citizens in their town museum.

When and where did Harriet and John marry? Their first son JOSEPH RICHARD ROBERTS was born 1855 in Centerville, Appanoose Co., IA. The family later lived in Lucas Co., IA, and then near Des Moines, IA. Joseph was 20 years older than his second wife CARRIE EUGENIA WESTON. His first wife and all of their children died of consumption (TB); what was her name; this may have occurred in IN or IL.

My branch of the family moved to Rockcastle Co., KY, and in searching those records I found the following information on ELIZABETH BUNDREN, who I am sure was a Bundrant."

Birth records show ALBERT HAYES born 5 June 1875 to COLBY HAYES and ELIZABETH BUNDREN. Birthplace of the mother was VA.

Death records show ELIZABETH HAYES, female, age 28, d. 1 June 1876 of consumption. Place of birth TN, parents HYRAM BUNDREN and MARY BUNDREN, born b. TN.

The 1870 census of Rockcastle Co., KY, page 16, family 116, household 103 shows COLBA HAYSE, age 46, b. TN, wife Elizabeth, 20 b. TN, married Sept. within the year. In the household were JAMES H. HAYSE, 21 b. TN, MATILDA E. HAYSE 18 b. KY, married Oct. within the year; also MATILDA J. HAYSE, 22 b. TN, ELVIRAH HAYSE 19 b. KY, MARY HAYSE 17 b. KY, and WILLIAM HAYSE, 79 b. NC.

William Hayse/Hayes was b. ca. 1791 NC, d. 10-1874 Rockcastle Co., the son of GEORGE HAYES and MARY JUDAH MILLS. William's wife was JANE RUCKER b. 10-23-1802 Grainger Co., TN, d. 7-28-1867 Rockcastle Co., the dau. of COLBY RUCKER and SARAH ROBERTS.
